Jenkins, P.C. include <https://amyjenkinslaw.com> and TLOOALJ. The TLOOALJ website is a vacation rental site. By using the TLOOALJ website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, TLOOALJ may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase TLOOALJ's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

TLOOALJ collects and uses your personal information to operate its website(s) and deliver the services you have requested.

TLOOALJ may also use your personally identifiable information to inform you of other products or services available from TLOOALJ and its affiliates.

## **Sharing Information with Third Parties**

TLOOALJ does not sell, rent or lease its customer lists to third parties.

TLOOALJ may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to TLOOALJ, and they are required to maintain the confidentiality of your information.

TLOOALJ may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on TLOOALJ or the site; (b) protect and defend the rights or property of TLOOALJ; and/or (c) act under exigent circumstances to protect the personal safety of users of TLOOALJ, or the public.

## **Tracking User Behavior**

TLOOALJ may keep track of the websites and pages our users visit within TLOOALJ, in order to determine what TLOOALJ services are the most popular. This data is used to deliver customized content and advertising within TLOOALJ to customers whose behavior indicates that they are interested in a particular subject area.

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by TLOOALJ. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the TLOOALJ website.

## **Use of Cookies**

The TLOOALJ website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
